## **Bennelong Market Neutral Fund**

## Introduction

This Target Market Determination (TMD) is required under section 994B of the *Corporations Act 2001* (Cth) (the Act). It describes the class of investors identified as the target market for the financial product and its distribution and review (specifically, distribution conditions, review triggers and periods, and reporting requirements). #### Target market summary

This product is intended for use as a satellite allocation for an investor seeking capital growth, who has a high or very high risk and return profile for that portion of their investment portfolio. It is likely to be consistent with the financial situation and needs of an investor with a minimum investment timeframe of 5 years, who is unlikely to need withdrawals on less than one month's notice.

#### Appropriateness

#### Investment products and diversification

#### Investor's risk (ability to bear loss) and return profile

This TMD uses the Standard Risk Measure (SRM) to estimate the likely number of negative annual returns for this product over a 20 year period, using the guidance and methodology outlined in the Standard Risk Measure Guidance Paper For Trustees. (Note the bands risk categories in the SRM guidance differ from the bands risk categories used in this TMD). However, SRM is not a complete assessment of risk and potential loss. For example, it does not detail important issues such as the potential size of a negative return (including returns under conditions of market stress) or that a positive return could still be less than an investor's requirements to meet their investment objectives/needs. The SRM methodology may be supplemented by other risk factors. For example, some products may use leverage, derivatives or short selling; may have liquidity or withdrawal limitations; may have underlying investments with valuation risks or risks of capital loss; or may otherwise have a complex structure or increased investment risks, which should be documented together with the SRM to substantiate the product risk rating.

An investor's desired product return profile would generally take into account the impact of fees, costs and taxes.

	<ul> <li>the potential impact of the underlying investments' liquidity or any possible constraints on accessing funds (such as the ability to delay or stagger redemptions)</li> </ul>
	<ul> <li>where a product is held on investment platforms, the length of time platforms take to process requests for redemption for underlying investments, and</li> </ul>
	<ul> <li>where access to investment proceeds is likely to occur through a secondary market, the liquidity of the market for the product and likely realisable value on market, including in times of market stress.</li> </ul>
Distributor Reporting	
Significant dealings	Section 994F(6) of the Act requires distributors to notify the issuer if they become aware of a significant dealing in the product that is not consistent with the TMD. Neither the Act nor ASIC defines when a dealing is 'significant' and distributors have discretion to apply its ordinary meaning.
	The Issuer will rely on notifications of significant dealings to monitor and review the product, this TMD and its distribution strategy, and to meet its own obligation to report significant dealings to ASIC.
	Dealings outside this TMD may be significant because:
	<ul> <li>they represent a material proportion of the overall distribution conduct carried out by the distributor in relation to the product, or</li> </ul>
	<ul> <li>they constitute an individual transaction which has resulted in, or will, or is likely to result in significant detriment to the investor (or class of investor).</li> </ul>
	In each case, the distributor should have regard to:
	<ul> <li>the nature and risk profile of the product (which may be indicated by the product's risk rating or withdrawal timeframes)</li> </ul>
	<ul> <li>the actual or potential harm to an investor (which may be indicated by the value of the investor's investment, their intended product use or their ability to bear loss), and</li> </ul>
	<ul> <li>the nature and extent of the inconsistency of distribution with the TMD (which may be indicated by the number of red and/or amber ratings attributed to the investor).</li> </ul>
	Objectively, a distributor may consider a dealing (or group of dealings) outside the TMD to be significant if:
	• it constitutes more than half of the distributor's total retail product distribution conduct in relation to the product over the quarter
	<ul> <li>the investor's intended product use is solution/standalone</li> </ul>
	<ul> <li>the investor's intended product use is core component or higher and the investor's risk/ return profile is low, or</li> </ul>
	• the relevant product has a green rating for investors seeking extremely high risk/return.
